## **Ethibel PIONEER en Ethibel EXCELLENCE Investment Registers**

Forum ETHIBEL composes the Ethibel PIONEER and Ethibel EXCELLENCE Investment Registers. The Ethibel PIONEER Investment Register contains companies, which are sector leaders in terms of Corporate Social Responsibility (CSR). The Ethibel EXCELLENCE Investment Register also includes companies, which perform better than average in their sector.

The rating is assigned, based on an assessment process during which all CSR domains are evaluated and all stakeholders relevant to the company are consulted. In other words, an in-depth analysis reveals whether a company is eligible for ethical or sustainable investments. Companies are informed about their inclusion in the Ethibel Investment Registers and are entitled to communicate this internally as well as externally.

## **Ethibel PIONEER and Ethibel EXCELLENCE labels**

Besides the composition of Investment Registers, Forum ETHIBEL also awards labels to investment products. Financial products with the Ethibel PIONEER or Ethibel EXCELLENCE label guarantee that only shares and bonds from the Investment Register will be invested in.

## **Ethibel Sustainability Indices**

Forum ETHIBEL created the first Ethibel Sustainability Indices in 2001. These indices contain a basket of companies from the Investment Register and are therefore a good indication for the performance of sustainable investments. Companies are informed about their inclusion in the Ethibel Sustainability Indices and are entitled to communicate this internally as well as externally.
